Eligibility Criteria for the bidder:

- 1. The Bidder submitting the offers should be a Registered Company in India under the Companies Act, 1956 and should have been in existence for a period of at least 5 years as of <u>31.03.2021</u>
- 2. The bidder should have an average annual turnover of <u>Rs. 5 Crore (Minimum)</u> in last three financial years. Providing/procurement of Fishery Items I.e. Fishing nets, boats, vessels etc. The copies of Audited Annual Accounts shall be attached along with the bid. (Form no. E-1).
- 3. The bidder should be an Agency / organization engaged in the execution of projects for providing/procurement of Fishery Items I.e. Fishing nets, boats, vessels etc. for a period of at least 5 years as of 31.03.2021.
- 4. The bidder should have successfully completed similar work with any Government agency / Semi Government/PSU during last 5 years as on date of submission of bid. Three orders with similar items in this bid, each consisting of minimum supply of total 50 Boats. (Form no. E-2)
- 5. The bidder must have one office in Gujarat. Please attach the copy of any two of the following: Property tax bill/Electricity Bill/Telephone Bill/ GST Registration/Lease agreement. (Form no. E-3). In case, bidder do not have office in Gujarat, bidder should give undertaking to open office in Gujarat within 30 days from the date of award of contract.
- 6. Bidder should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Gujarat or any of the PSU in the state of Gujarat at the time of bidding. (Certificate / affidavit mentioning that the Bidder is not blacklisted by Government of Gujarat or any of the PSUs in the state of Gujarat due to engagement in any corrupt and fraudulent practices)

Note: Bidders who wish to participate in this bid will have to register on <u>https://www.nprocure.com</u>. Further bidders who wish to participate in online bids will have to procure Digital Certificate as per Information Technology Act 2000 using which they can sign their electronic bids. Bidders can procure the same from (n) code solutions – a division of GNFC Ltd., or any other agency licensed by Controller of Certifying Authority, Govt. of India. Bidders who already have a valid Digital Certificate need not procure a new Digital Certificate.

The terms and conditions are as follows:

- The last date of submission of bid on the website <u>https://www.nprocure.com</u> is as per the tender. No physical bids will be accepted under normal circumstances. However, GTDC reserves the right to ask the bidders to submit the bid and/or any other documents in physical form.
- **2.** The bid is non-transferable.
- 3. The bidder will have to supply and provide operational training of supplied Items to beneficiaries at District Project Offices located all across Gujarat State.
- 4. The Bidder shall bear all the costs associated with the preparation and submission of its bid, and GTDC will in no case will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
- 5. The bidder has to upload the compliance letter on its letter head duly signed by the authorized signature & other supporting documents as asked for in the bid in scanned format. Failing to submit the same or non-compliance/deviation from any bid terms and conditions, eligibility criteria or technical specifications may result in rejection of the bid.
- 6. The Bidder has to examine all instructions, forms, terms, conditions and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the biding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.
- 7. Amendment of Bidding Documents (Corrigendum)
 - 7.1 At any time prior to the deadline for submission of bids, GTDC may, for any reason, whether its own initiative or in response to the clarification request by a prospective bidder, modify the bidding documents.
 - 7.2 The corrigendum will be published on website <u>https://www.nprocure.com</u> & <u>https://adijatinigam.gujarat.gov.in/</u>
 - 7.3 In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids GTDC, at its discretion, may extend the deadline for the submission of bids.
- 8. Bid Currency Prices shall be quoted in Indian Rupees only.
- 9. The Bidder will have to submit Nonrefundable Bid Processing Fees of Rs. 15,000/- and Earnest Money Deposit (E.M.D.) of Rs. 18,00,000 /- on or before the date and hours of bids submission in a sealed cover at GTDC office with the heading "Bid Processing fees and EMD for the "Bid for Rate Contract for procurement of Fishing Boats & Accessories for Gujarat Tribal Development Corporation (GTDC), Gujarat State." Bid processing fees must be in the form of Demand Draft in the name of "Gujarat Tribal Development Corporation" payable at Gandhinagar along with the covering letter. Please affix the stamp of your company on the overleaf of demand draft. EMD shall be submitted in the form of Demand Draft OR in the form of an unconditional Bank Guarantee (which should be valid up to validity of bids + 90 days) of any Nationalized Bank (operating in India having branch at Ahmedabad / Gandhinagar) as per the G.R. no. EMD/10/2018/18/DMO dated 16.04.2018 issued by Finance Department or further instruction issued by Finance department time to time in the name of "Gujarat Tribal Development Corporation" payable at Gandhinagar (as per prescribed format given at Annexure) and must be submitted along with the covering letter.

Please affix the stamp of your company on the overleaf of in case of demand draft.

Note: Failing to submit physical covers of EMD and bid processing fees at GTDC on or before **the timeline mentioned in the bid** may lead to the rejection of the bid.

- 10. In case of non-receipt of Bid Processing fees & EMD as mentioned above within prescribed time the bid will be rejected by GTDC as non-responsive.
- 11. Unsuccessful/Disqualified bidder's E.M.D. will be returned within 30 days after opening of financial bid & selection of successful bidder.

- 12. In exceptional circumstances, GTDC may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. A Bidder may refuse the request without forfeiting its E.M.D. A Bidder granting the request will not be permitted to modify its bid.
- 13. The Successful bidder has to submit copy of each purchase order, acceptance of purchase order & copy of PBG, offer of the material for inspection at GTDC office.
- 14. The Successful bidder has to submit Performance Bank Guarantee @ 5% of total order value within 15 days from the date of issue of Purchase order (for 39 months) from All Nationalized Bank including the public-sector bank or Private Sector Banks or banks (operating in India having branch at Ahmedabad/ Gandhinagar) as per the G.R. no. EMD/10/2018/18/DMO dated 16.04.2018 issued by Finance Department or further instruction issued by Finance department time to time. (The draft of Performance Bank Guarantee is attached herewith).
- 15. Successful bidder will have to sign the contract upon receiving the Purchase order with the purchaser(s) within 15 working days from the date of Purchase order. (The draft of the Contract form is attached herewith)
- 16. The successful Bidder's E.M.D. will be returned upon the Bidder signing the Contract, and furnishing the Performance Bank Guarantee @ 5% of the total order value, offer of inspection of the ordered material, submission of warranty certificates as asked in the bid and after completion of bid validity whichever is later.
- 17. The E.M.D. may be forfeited:
 - (a) if a Bidder withdraws its bid during the period of bid validity
 - (b) In case of a successful Bidder, if the Bidder fails:
 - (i) If the bidder is found to be involved in fraudulent practices.
 - (ii)If the bidder fails to submit the copy of purchase order & acceptance thereof.

(iii)"If the successful bidder fails to submit the Performance Bank Guarantee & sign the Contract Form within prescribed time limit, the EMD of the successful bidder will be forfeited. GTDC also reserves the right to blacklist such bidder from participating in future tenders if sufficient cause exists

- 18. Termination for Default
 - 22.2 The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder (after providing notice/cure period of 30 days), terminate the Contract in whole or part
 - a) if the bidder fails to deliver any or all of the Goods within the time limit as mentioned in the bid, or within any extension thereof granted by the Purchaser or
 - b) if the Bidder fails to perform any obligation(s) under the Contract/Purchase order.
 - c) If the Bidder, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

For the purpose of this clause:

"Corrupt practice" means the offering, giving, receiving or soliciting of any thing of value of influence the action of a public official in the procurement process or in contract execution.

"fraudulent practice: a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the purchaser, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the purchaser of the benefits of free and open competition;"

- 22.2 In the event the Purchaser terminates the Contract in whole or in part, pursuant to Clause 18.1 above, the Purchaser may procure, upon such terms and in such manner, as it deems appropriate, Goods or Services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or Services. However, the Bidder shall continue the performance of the Contract to the extent not terminated.
- 19. Price shall be inclusive of all freight, forwarding, transit insurance and installation charges.
- 20. Prices shall be in Indian Rupees. The prices shall strictly be submitted in the given format. The tax (GST) components as applicable shall be mentioned separately in the respective columns.

- 21. Late Bids The bidder will not be able to submit the bid after final submission date and time.
- 22. Modification and Withdrawal of Bids
 - 22.1 No bids will be allowed to be modified after the final submission of bids.
 - 22.2 No bid will be allowed to be withdrawn in the interval between the deadline for submission of bids and the expiry of the bid validity. Withdrawal of a bid during this interval will result in the forfeiture of bidder's E.M.D.
- 23. EMD and Bid Processing Fee and Bids will be opened in the presence of Bidder's representatives, who choose to attend. The Bidder's representatives who are present shall sign a register/attendance sheet evidencing their attendance. The representative will be held responsible for all commitments made on behalf of the bidder and that will be considered valid for all further dealings related to this tender process. In the absence of the bidder(s), the tender committee may choose to open the bids as per the prescribed schedule.
- 24. The Bidder's names, Bid modifications or withdrawals, discounts and the presence or absence of relevant E.M.D. and such other details as GTDC officer(s) at their discretion, may consider appropriate, will be announced at the opening.
- 25. **Evaluation of the bids:** After the closing time of submission, GTDC committee will verify the submission of Bid Processing Fees & EMD as per bid terms and conditions. Evaluation of the Technical bids will be further conducted by GTDC committee. Any kind of non-compliance, be it in terms & conditions of this Bid Document or Technical Specifications of the items required under this bid or any other, observed during the Technical Evaluation will lead to rejection of bid, without giving any reasons to bidder thereof. The decision of the Tendering Evaluation Committee and Chairman of GTDC will remain final in this regards and binding unconditionally on bidders. The financial bid of the technically qualified bidders will be opened. Successful bidder will be decided based on lowest quoted rates without tax as mentioned in the financial bid section. The purchaser reserves the right to call for further negotiations.
- 26. The rate contract shall be valid for a period of 1 Year from the date of selection. The selection contract may be renewed further for a period of 1 Year based on the performance.
- 27. **Inspection of Goods:** The bidder will have to offer inspection in the manner as decided by GTDC before delivering to the respective sites. The arrangement of inspection of goods has to be done by supplier. Any deviation found in the specification of the produced goods or delivered goods after inspection from the tender specifications will lead to the cancellation of the order, forfeiture of EMD/PBG and prohibition in the participation in the future purchase of Government of Gujarat. GTDC will not be responsible for any time delay which may arise due to any deviation from the bid technical specification found at the time of inspection and the bidder has to deliver and install the ordered goods within prescribed time limit.
- 28. Delivery & installation: Within 45 Working days from the date of purchase order at respective site/locations.
- 29. In case of successful bidder is found in breach of any condition(s) of bid or supply order/work order, at any stage during the course of supply / installation or warranty period, the legal action as per rules/laws, shall be initiated against the successful bidder and EMD/PBG shall be forfeited, besides debarring and blacklisting the bidder concerned for the time period as decided by Govt., for further dealings with GTDC.
- 30. Bids shall be valid up to 120 days from the opening of financial bids. A bid valid for a shorter period shall be rejected as non-responsive. If required, GTDC may extend the bid validity for further period from the date of expiry of bid validity in consultation with the successful bidder.
- 31. Bidder must ensure that the warranty support & service should be available up to delivery locations to provide repairing cum replacement services of faulty equipment within 7 days. Bidder is required to provide the name & address & contact details of the firm for providing warranty support & repairing cum replacement service up to delivery locations.

32. Penalty Clause for delay in delivery & installation

- 32.1 If the bidder fails to deliver and install the requisite materials/Goods within the time limit as mentioned in the bid, then a sum equivalent to one percent (1 %) of the total contract value shall be deducted from the payment for each calendar week of delay or part thereof.
- 32.2 The amount of penalty for delay in delivery & installation shall be subject to a maximum limit of 10% of the total contract value.

- 32.3 Delay in excess of 10 weeks will be sufficient to cause for termination of the contract. In that case the Performance Bank Guarantee of the bidder will be forfeited.
- 32.4 In case, the selected bidder does not supply the ordered items for any reason, the bidder will be liable to pay the difference amount to the purchaser, over and above the performance guarantee, which indenter department has to pay to the next or other selected bidder for purpose of the said items.

33. Warranty

- ✓ Comprehensive onsite warranty for 3 years from the date of successful delivery of Boats.
- ✓ Comprehensive onsite warranty for 1 year from the date of delivery for all items excluding Boats.
- 33.1 If any Equipment continuous trouble, say more than 3 times in one month during the warranty period, the bidder shall replace the systems with new system without any additional cost to the purchaser.
- 33.2 Maintenance service: Free maintenance services shall be provided by the Bidder during the period of warranty.
- 33.3 In case, bidder is not providing satisfactory support & doing unwarranted delay in providing warranty support, GTDC offices reserves right to repair the equipment at risk & cost of the bidder.

Operational/Warranty period Penalty:

- 33.4 During warranty period, if the complaint is not resolved within 7 days from the date of lodging the complain, the penalty of Rs. 300 per day for Boats and within 14 days the penalty of Rs. 200 per day for other items will be levied. However, if the complaints not resolved within 14 days then from 15th day to 30th day, penalty would be levied @ 150% and from 15th day onwards penalty @ 200% of the above rates would be levied. The amount of penalty will be recovered from the Performance bank guarantee during warranty period.
- 33.5 The amount of Operational/Warranty period Penalty shall be subject to a maximum limit of 5% of the total contract value. Subsequent to which the PBG will be forfeited & appropriate statutory actions against the supplier may be taken.

Note: Successful bidder should submit the Performance Bank Guarantee @ 5% of total order value for the duration of 39 months as per bid requirements. In any case, bidder is required to maintain 5% PBG at all time during the period of contract. In case of any penalty claimed from the submitted PBG during the contract period, the successful bidder is required to submit the additional PBG of the amount equal to the penalty claimed for the duration up to the validity of original Bank Guarantee.

For example: For 3 years warranty "X" amount of penalty will be claimed during the 5th month of contract period (for, then bidder is required to submit the additional PBG of "X" amount for the period of 34 months i.e. 39 months - 5 months.

- 34. **Payment:** Payment for Equipment and Services shall be made by the Indenting Department in Indian Rupees as follows:
 - 34.1 No advance payment will be made.
 - 34.2 For boats: 90 % payment after successful inspection and delivery of the Boats. The inspection will be done as decided by GTDC. Remaining 10% payment will be made yearly basis at the end of 1st year & 2nd year.
 - 34.3 For remaining equipment: 95% payment after successful inspection and delivery of the other equipment. The inspection will be done as decided by GTDC. Remaining 5% payment will be made after completion of 1 year of warranty period.
- 35. GTDC reserves the right to change any bid condition at any item even after inviting the bids, with/without prior notification.
- 36. GTDC's Right to accept any Bid and to reject any or all Bids GTDC reserve the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to awarding the Contracts, without thereby incurring

any liability to the affected Bidder or bidders or any obligation to inform the affected Bidder or bidders of the grounds for such decision.

- 37. As this is a rate contract, the quantity mentioned in the bid is unit. During the period of rate contract, the successful vendor will have to accept purchase orders. The quantity is only indicative for reference purpose & it does not give guarantee for order.
- 38. Force Majeure Shall mean and be limited to the following:
 - a) War / hostilities
 - b) Riot or Civil commotion
 - c) Earthquake, flood, tempest, lightening or other natural physical disaster.
 - d) Restrictions imposed by the Government or other statutory bodies which prevents or delays the execution of the order by the BIDDER.

The BIDDER shall advise GTDC by a registered letter duly certified by the local statutory authorities, the beginning and end of the above causes of delay within seven (7) days of the occurrence and cessation of such Force Majeure Conditions. In the event of delay lasting over two months, if arising out of causes of Force Majeure, GTDC reserves the right to cancel the order.

Completion period may be extended to circumstances relating to Force Majeure by the GTDC. Bidder shall not claim any further extension for completion of work. GTDC shall not be liable to pay extra costs under any conditions.

The BIDDER shall categorically specify the extent of Force Majeure conditions prevalent in their works at the time of submitting their bid and whether the same have been taken in to consideration or not in their quotations. In the event of any Force Majeure cause, the BIDDER shall not be liable for delays in performing their obligations under this order and the delivery dates can be extended to the BIDDER without being subject to price reduction for delayed delivered, as stated elsewhere.

It will be prerogative of GTDC to take the decision on force major conditions and GTDC decision will be binding to the bidder.






Fig. 9. Chokla jal (Surface drift net) operatd in Gujarat
